# PRESBYTERY DIGEST

A summary of actions & information from the meetings of Pittsburgh Presbytery September 20, 2018

Crestfield Camp & Conference Center

The meeting was called to order at 10:00 AM by the Rev. Dr. Trent Hancock, Moderator. The Rev. Dr. Sheldon Sorge gave a sermon titled, *I May Be Wrong*. The Sacrament of the Lord's Supper was served along with a litany for all the saints, and especially for the elders and pastors of Pittsburgh Presbytery who have joined the Church Triumphant in the last twelve months, listed by name in a bulletin insert. A special remembrance of the life and work of the Rev. Fred Rogers was led by the Rev. Dennis Molnar. An offering of \$1,669.11 was received for equal distribution to the <u>Lazarus Fund</u> and the <u>Hunger Fund</u>. This amount will be matched by the <u>Pittsburgh Presbyterian Foundation</u>.

#### From the Executive Committee

#### **Announced** the following:

- in light of the General Assembly approved study of funding of higher governing bodies, the Executive Committee declines to take any further action at this time in response to a request the presbytery remit to higher councils only the per capita contributions that it collects
- the allocation of funds from the Bellefield Church dismissal settlement
  - ➤ \$50,000 annually, for a minimum of three years, for the ministry of the new worshiping community Commonwealth of Oakland, to the members and neighbors of the university community in Oakland
